- If items are not returned the same day they were rented, additional daily rental charges will apply.
- It is the responsibility of the renter to check the returned tubes and accessories in with the attendant before leaving.
- Consumption of alcoholic beverages on the premises of **THE GENERAL DAN TUBING CO. & DANBURY GENERAL STORE** is strictly **PROHIBITED**
