- If items are not returned the same day they were rented, additional daily rental charges will apply
- It is the responsibility of the renter to check the return tubes and accessories in with the attendant before leaving.
- Consumption of alcoholic beverages on the premises of THE GENERAL DAN TUBING CO. & DANBURY GENERAL STORE is strictly PROHIBITED.
- Possession or consumption alcoholic beverages on the DAN RIVER is unlawful.
